

# Margel German Shepherds Puppy Holding Contract

A holding fee of \$500.00 is required to hold this puppy for the Buyer until the said puppy is a minimum of 8 weeks old. There are NO REFUNDS ON PUPPY HOLDING FEES. The buyer agrees that they have checked with landlords, employers, homeowners associations, or anyone needed for approval of a german shepherd dog. Further, they have checked with their physician in regards to allergies related to dogs. Failure of the Buyer to complete this purchase would subject Seller to lose opportunities to sell the puppy to some other Buyer and retention of the deposit is meant to compensate the Seller for their possible loss. This fee signifies the intent on the part of the Buyer to follow through with the purchase of this puppy. The Seller reserves the right to void this transaction and keep the holding fee if we learn of any reason why Buyer might not be suitable for the puppy – (i.e. Buyer is found to be an animal abuser, violent person, representative of a Pet Store, representative of pharmaceutical research laboratory, etc) or if the Buyer LIES to the seller in any way the holding fee will not be refunded.

If through some tragic accident, the puppy were to die or otherwise be seriously injured before it goes to it's new home, then, of course the deposit will transfer to the next available litter. If full payment is not received within 5 days after the puppy's 8 week birthday the puppy will be re-listed and offered to other parties. The puppy will be available for the Buyer to pick up personally at Margel German Shepherds. If the buyer is having the puppy shipped full payment is to be paid by the 7th week birthday. This payment must also include shipping costs, health certificate, crate, and any other costs associated with shipping. If payment is not received by 7th week birthday puppy will be re-listed and offered to other parties. Buyer understands if they are shipping the puppy, they are responsible for figuring out how they are getting their puppy well in advance so payment is made on time. This date is based on our estimation of when the puppy will be naturally weaned and ready to leave its Mom. Puppies stay with their Moms at an absolute MINIMUM of 8 weeks. This written agreement contains all the terms of this Puppy Holding Fee. No refunds will be given, all fees are NON-REFUNDABLE. ALL SALES ARE FINAL to ensure that the Buyer can immediately reserve the Puppy of their choice. Buyer and Seller agree that this Agreement is in full force by virtue of email exchange of a completed copy of this agreement between Seller and Buyer. All disputes are subject to resolution in the Seller's State of Michigan.

Margel german shepherds reserves the right to keep first pick of any litter, of either sex, at anytime. In this rare case the puppy picking order would then continue in the same order as planned. It is expected that Buyer will handle themselves in a respectful manner at all times. Verbal attacks/Disrespectful communication will not be tolerated EVER! We reserve the right to void this contract if Buyer doesn't conduct themselves respectfully. In such cases holding fee will be FORFEITED.
